 We operate a Nursery, Day Care, Nature Preschool, School Age Care and a Summer Recreation Camp in our childcare centre. We provide support & services to young parents in the community. We run a transition house for women & children leaving abusive situations. We operate a 24/7 home for head injured men. We provide low-cost rentals units for older women and adults with children and run an apartment building for low income and head injury survivors. We provide case management and community support for head injured survivors living on their own and to FASD and Autism adults. We operate a 77 unit Assisted Living Senior Centre. We provide services & counseling to our tenants, especially women and children who left abusive situations. We maintain a database of respite providers in the Greater Victoria area that parents can access. We run a Respite Program that provides free hotel rooms or a dinner out for parents who have a special needs child so they can have a break.
