LEADER IN TRAINING APPLICATION FORM

Our Leader in Training (LIT) program is a three week summer leadership program designed for participants who are 14-17 years of age and ready to take on new responsibilities in a day camp setting. Through this transformative program our LIT participants have the chance to hone their leadership skills, practice a variety of teaching/facilitation techniques and navigate their position as role models for children and youth. These skills are further enhanced through direct interaction with campers at our center and out in the community on field trips.

How does the program work? LITs play a key role in the daily routine of our day camp. LITs are matched with experienced staff who will mentor them during the three week training period during which they will learn to lead activities in a group of 5-12 year olds. Participants have the opportunity to acquire staff-like responsibilities such as leading games, crafts, songs, and stories as well as gain valuable skills on how to work in a team environment.
